1. Introduction

1. As per the gazette notification dated 2.6.2023 of Under Graduate Medical Education Board 2023, all admissions to undergraduate courses shall be done through common counselling.
2. Rajasthan state NEET UG counselling is done for admission to all Government Medical/Dental Colleges, RUHS CMS, RUHS CDS, ESIC MC and all Private Medical and Dental Colleges of Rajasthan.
3. 15% seats of all Government Medical/Dental Colleges, RUHS CMS, RUHS CDS and Govt. Society Medical Colleges of the State will be filled from All India Quota for which counseling is done by Medical Counselling Committee and remaining 85% State quota seats (including Management/ NRI seats) will be allotted through Rajasthan state NEET UG counseling along with all seats of Private Medical and Dental colleges of Rajasthan.
4. Rajasthan State NEET UG Counselling 2026 shall be done by NEET UG Medical & Dental Admission/Counseling Board 2026 constituted by the State Government. All the allotments will be done by the above Admission/ Counselling Board comprising of all Principals/Representatives of Principals of Medical/Dental Colleges of the State of Rajasthan.
5. The Rajasthan NEET UG counseling will be conducted as per the rules and regulations given by National Medical Commission (NMC)/ National Dental Commission (NDC) and directions from the Central Govt., State Govt. and in compliance to latest orders of Hon'ble Supreme Court and Hon'ble Rajasthan High Court.
6. The role of State NEET UG Medical & Dental Admission/Counseling Board is limited to allotment of seats to the participating candidates, as per their merit and choice, which starts only after receiving the list/data/Information of successful/qualified candidates from National Testing Agency (NTA) i.e. the NEET (UG) examination conducting body, received by above Admission/Counselling Board through the State Government/ Directorate of Medical Education (DME).
7. Allotment of Course and College to the candidate shall be strictly made according to the merit, the choice(s) filled by the candidate and availability of the seats as per the reservation policy of the state and in accordance with the rules and the directions laid down by Hon'ble Supreme Court of India/ Hon'ble Rajasthan High Court/NDC/NMC/Government of Rajasthan, **but the admission will be subject to verification of his/her documents/credentials for which the decision of the Principal of the concerned allotted college or the State NEET UG Medical & Dental Admission/Counseling Board shall be final.**
8. The allotment of seat to the candidates is made based on the NEET-UG Examination conducted by National Testing Agency (NTA). **Only NEET UG 2026 qualified and candidates registered with Rajasthan State UG Admission/Counseling Board 2026 shall be eligible for admission in state quota counselling.**

2. Instructions for Candidates

NOTE: Qualified and eligible candidates are required to register on the Rajasthan State Counselling website i.e. <https://ug.neetrajasthan.com> in order to participate in the state counselling process for allotment of seat. State NEET UG Medical & Dental Admission/Counselling Board 2026 does not allot any seat either on nomination basis or manually.

Candidates are advised to refer the website regularly for updated and relevant information.

Candidates are further advised to fill the application form on their own and not through Any agent or third party

1. Candidates must go through the Information bulletin, instructions for filling online application form, seat matrix, all notification(s) and College Information sheets, Fee information sheets, bond conditions, etc., available at the website, before proceeding for the counseling process.
2. Candidates must have read agreed and accepted the counseling scheme and the terms and conditions of the counseling scheme for Rajasthan State NEET UG Counselling on completing the online application/registration form.
3. Application/Registration for Rajasthan State NEET UG counseling can only be submitted online through above mentioned website and only once by a candidate. Application/Registration submitted through any other mode shall not be considered. Any Candidate submitting more than one application/registration in same round will be debarred from the counseling process.
4. The candidates will be required to deposit security amount for participation in counseling through choice filling process and such **security deposit will be forfeited if a candidate who has been allotted a seat in the second and subsequent rounds does not join the respective institution. Security deposit will also be forfeited if the admission gets cancelled due to any reason for eg:- if the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or the candidate fails to produce the required documents at the time of admission within the stipulated time period.**
5. Candidates must be aware that registering for State NEET UG Counselling does not provide any rights to secure and undergraduate seat. The admission shall be subject to state merit, admission criteria and eligibility as per NMC norms.
6. Candidate must ensure that all information submitted through the online counseling registration and application/registration process is accurate, complete and factual. The information provided by the candidate shall be treated as final and self-certified. Therefore, candidates are advised to verify all details carefully before final submission. No request for correction, modification, or change in the information submitted during the counseling process will be entertained under any circumstances except if notified. The data entered by

the candidate at the time of registration on NTA portal will be used for counselling purposes including name, DOB, Category etc.,

7. Counselling board does not alter any information entered by the candidate at the time of online submission of application/registration forms for counseling under any circumstances.
8. The information regarding Stipend /fee structure/ course duration / bond amount / rendering of service must be checked by candidates prior to participation in counseling process. Candidates are advised to check the counselling website and also visit the college website for any query regarding information related to fee details/hostel accommodation/bond amount/stipend/surety bonds/service bonds prior to filling choices.
9. After choices get locked, they cannot be modified and any request regarding the editing/modifications of choices will not be entertained.
10. Candidates are advised to check their domicile status and related eligibility before registration and participation in counselling process.
11. Candidates are advised to keep visiting and checking the counselling website for schedule/latest updates/seat matrix/allotment results/notices/news and events pertaining to counselling. No Candidate will be individually informed/contacted for updating above details. No communication will be send directly to the candidate(s) and they must check the website regularly for updates. **Any complain resulting due to the flaw occurring because of non-visiting of website on regular basis shall not be entertained by Admission/Counselling Board.**
12. The Admission/Counselling authority reserves the absolute and unfettered right, at its sole discretion to alter, amend, modify, supplement, withdraw or implement any or of the provision, instruction, guidelines or procedures contained in this information bulletin as deemed necessary from time to time. In the event of any ambiguity, inconsistency, dispute or question arising with respect to the interpretation or application of any provision/instructions/terms/rules/eligibility criteria/counselling procedure/candidate registration process or any other matter contained herein, the interpretation, clarification and decision of the NEET UG Medical/Dental Admission/Counselling Board shall be final, conclusive and binding upon all candidates and other stakeholders and shall not be opened to challenge except and may be provided under the applicable laws.
13. Candidates are requested to use their own Mobile Number and Email ID (personal) during the Counselling registration process since the OTPs will be sent to the Email ID for verification.
14. This is to inform the candidates that all Admissions and Resignation (if allowed) will be made by the respective institution through online mode only. Candidate must obtain the resignation letter generated from the Counseling website from the College authorities after updation of resignation from the allotted seat at the respective college as no offline resignation of seat is permitted in this Counselling Process.
15. Candidates must download the allotment letter from the Counselling website and must preserve a copy of same with them for further needful during the study and completion of respective courses as these allotment letters may be required for registration in concerned authority/ies at the end of the courses.

16. All Candidates must furnish the primary and alternative bank account numbers (preferably of self/parent) with all required bank account and account holder details at the time of registration as the security amount will be refunded to the primary account with or to the alternate account (only in case of rejection of refund amount/transferred to primary account).
17. All refunds shall be processed after the completion of Counselling process. No request for refund of security amount during the Counselling process shall be entertained.
18. Candidates must note that the application/registration fee is non-refundable in all circumstances and no request for the refund of application/registration fees is considerable.
19. Candidates must check the reservation policy of the state prior to participation in Counselling process.
20. Allotment of seat to reserved category candidates including NRI candidate shall be subject to production of valid requisite certificate.
21. OBC – NCL, MBC – NCL and EWS candidate(s) must upload the valid state certificate of their category applicable for the current academic session that is valid for the admission year 2026 while doing registration and also produce the same at the time of reporting for their reservation eligibility. **EWS certificate should be valid and issued for the year 2026-27.**
22. NRI Candidates are advised to check the conditions of eligibility as per Honorable Supreme Court/Honorable Rajasthan High Court directions and state government order (Annexure 2) in this information bulletin and their eligibility shall be subject to production of all required valid documents as mentioned in the information bulletin.
23. PwBD/PwD Eligibility certificates issued from any one of the 62 MCC authorized Medical Assessment Boards (Annexure – 1 A) shall be considered for their reservation eligibility. The Candidates must upload this certificate along with their permanent UDID card(s) (issued by the department of empowerment of Persons with Disabilities of the State) on the counseling website at the time of registration which will be downloaded and verified by the counseling authorities. No PwBD/PwD candidate will be required to come in person for verification of PwBD/PwD Status. The eligibility certificate issued as per NMC/MCC notification (Annexure – 1) for the academic session 2026-27 shall only be considered valid.
24. In case the eligibility certificate/UDID card uploaded/submitted by the candidate is found to be **FAKE**, the seat of the candidate will be cancelled along with forfeiture of the security deposit and legal action will be taken against such candidate(s).
25. Any grievance related to the counseling process shall be sent to the provided Email Id available on the counseling website and redressal of the grievance shall be done at the earliest possible depending on the issue raised in the grievance.
26. Candidates are advised to contact on the provided contact numbers in case of technical issues and the team involved in counseling process shall be ready to help at the earliest.
27. Candidates are advised to check all information/Updates on the Counselling website only. They are requested not to believe on fake/ Malicious websites and fraudulent/Spam messages.
28. Candidates must ensure to preserve their credentials, login Ids and passwords/OTPs if any during participation in counseling process. Admission/Counselling authorities should not be made responsible for revelation of passwords/information/OTPs to unauthorized persons.

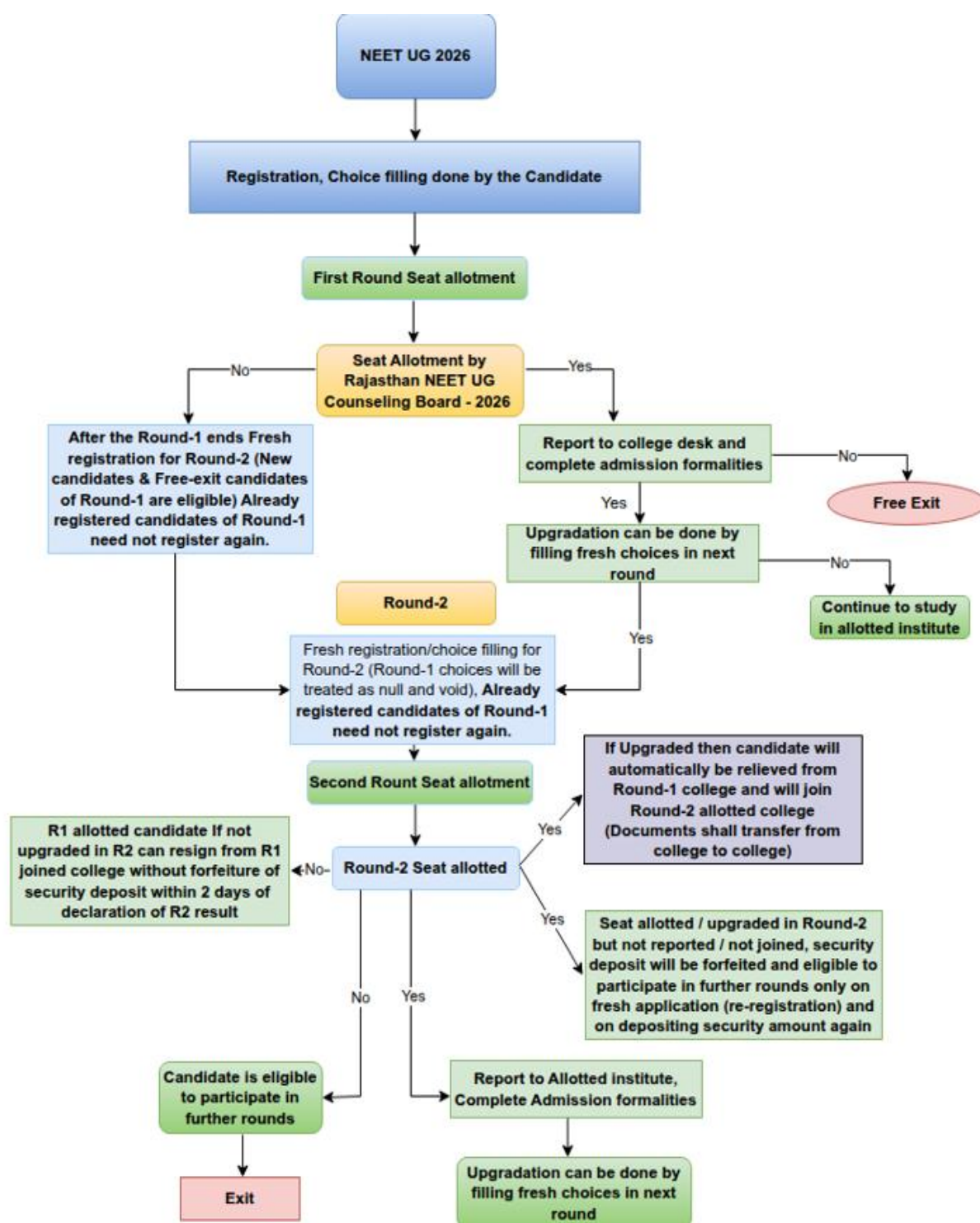
4. Counselling Scheme

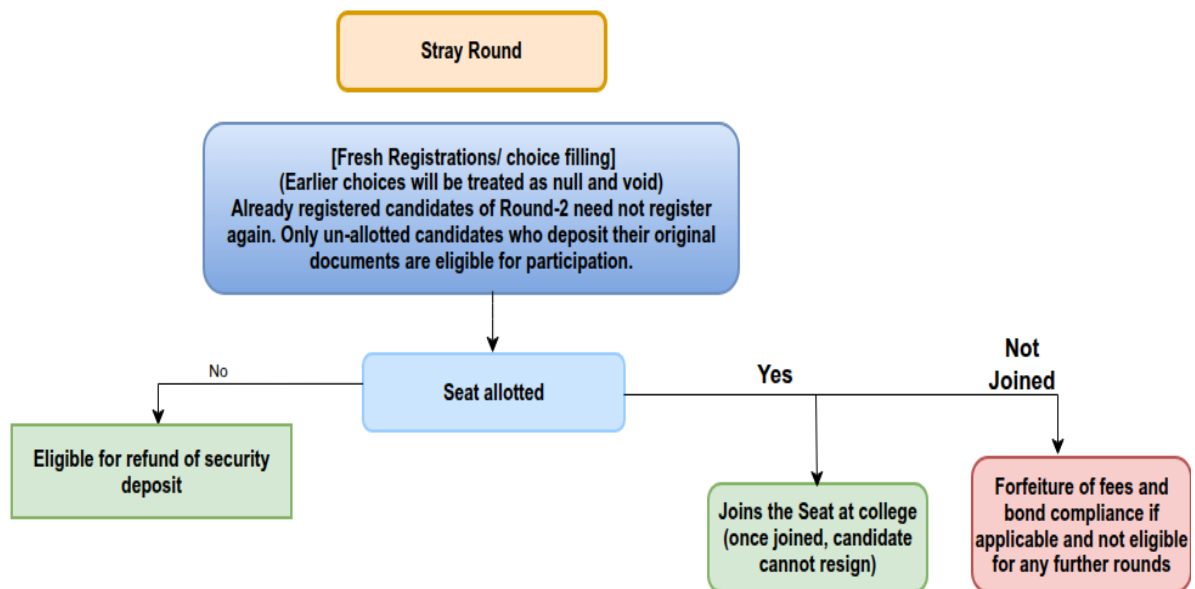
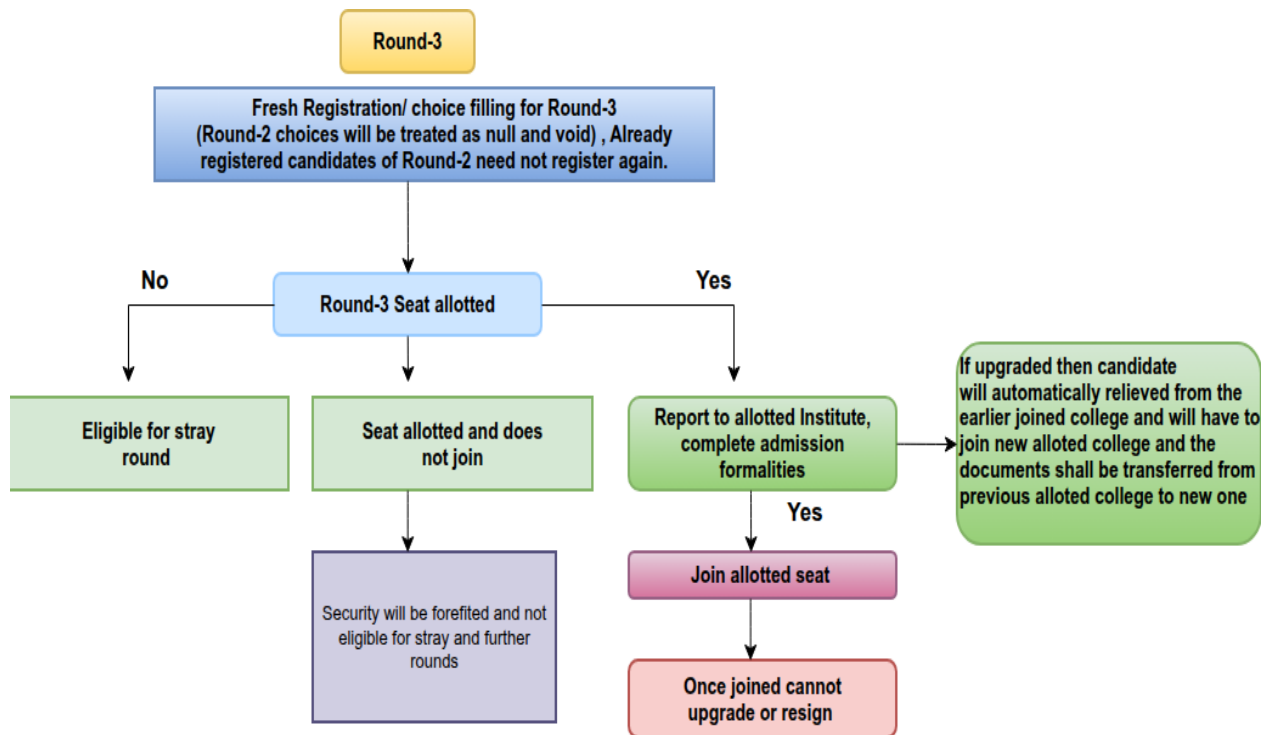
1. The scheme of Counselling was modified by the Hon'ble Supreme Court of India vide order dated 16.12.2021 in "SLA (C) No. 10487 of 2021 in the matter of Nihila P.P. v/s MCC & Ors. wherein as per orders of Hon'ble Supreme Court of India, **4 (FOUR) online rounds of Counselling** will be conducted i.e. **Round 1, Round 2, Round 3, and, Stray Vacancy Round. All four rounds of allotments including stray vacancy round shall be conducted On-Line. No Round shall be conducted off-line. No admission shall be made at College level.**
2. The Counselling process shall be conducted in four rounds. The facility for Upgradation will be available up to Round 3.
3. **Note*:-** Candidates are advised to take an informed decision of continuing in Third round of AIQ/Deemed/Central Universities as they would not be permitted to resign from 3rd round of AIQ/Deemed/Central Universities and they will also not be allowed to participate in State Counselling after **joining** in Third Round of AIQ. There will be Data sharing between Centre and the States and if any candidate has his/her name in the list of joined candidates in either of the lists, then name of such candidate shall be eliminated from the Stray Vacancy Round.
4. **Round 1 is free exit round** and if the candidate is not satisfied with the allotted seat, he/she may not join the seat and such non-joining of the candidate to the allotted seat will not result in forfeiture of the deposited security amount. The candidate(s) will be eligible for participation in the further rounds.
5. Upgradation shall be permitted in Round 2 and Round 3 by filling fresh choices again. Fresh registrations will be done in Round 2 and Round 3. Already registered candidates need not register again, until his/her security deposit is forfeited in previous round and as per rules.
6. A Candidate **if not upgraded in Round 2 can resign within 2 days of declaration of Round 2 result without forfeiture of Security deposit.** There will be forfeiture of security deposit in case of Non joining after Round 2 allotments for candidates who are upgraded and newly allotted in Round 2. Such Candidates can only participate in further round after registering again (re-registration) and depositing the security amount again.
7. AIQ allotted candidates can resign (only in Round1 or 2) after joining in state with forfeiture of security deposit as per notification, if made available by MCC on their website in due course of time.
8. Non-joining to Round 3 allotted/upgraded seats will result in forfeiture of security deposit. Such candidate shall not be eligible for participation in the Stray Vacancy Round.
9. Only the candidates who have not been allotted any seat till Round 3 in state and MCC Counselling and the free exit candidates of Round 1, if not allotted any seat in further Rounds are eligible for participation in the Stray Vacancy Round subject to deposition of all

original documents along with requisite bond/s as consent towards participation and Joining of allotted seat in the Stray Vacancy Round. Bond compliance should be done in case of Non- joining on allotted seat in the stray vacancy round.

10. Once Joined in Round 3, candidates can't upgrade and will not be allowed to resign.
11. No resignations are permitted after joining of Round 2 seat. Resignations shall only be allowed as per notifications for AIQ Round 2 and Round 3 allotted candidates, as per notification.
12. Conversion of seats will be done during and after Round 3 allotments after exhaustion of reserved category lists by following the conversion algorithm as per reservation policy of State of Rajasthan. All category PwBD/PwD seats shall be converted to respective category seats and STA to ST and other reserved category seats viz. ST, SC, OBC-NCL, MBC-NCL & EWS will be converted to UR (un-reserved) seats.
13. After exhausting State Merit list during / after round 3, candidates selecting clause XI "Other" are eligible to apply to participate and will be considered for allotment against available vacant seats (Govt./Management/NRI)
14. The Counselling Scheme is provided below in flow chart for convenience of candidates.

5. Eligibility Criteria

Admission to candidates shall only be allowed as per the eligibility conditions to appear in NEET UG 2026 examination and candidates must check their eligibility for admission to MBBS/ BDS course as per the NTA document (NEET UG 2026 Information Bulletin issued by NTA).

I. Educational Qualification Eligibility

1. National Medical Commission has framed the Graduate Medical Education Regulations, 2023 as notified on 02.06.2023. Regulation 11(b) provides that candidates who have passed 10+2 or its equivalent with the subjects of Physics, Chemistry, Biology/ Biotechnology & English shall be eligible for appearing in NEET-UG and resultantly also be permitted to appear in counseling/admission process.
2. The National Medical Commission has declared vide public notice **No. U -14021/12/UGMEB-2023 dated 22.11.2023** that candidates who have undertaken study of the requisite subjects i.e. Physics, Chemistry, Biology / Biotechnology along with English even as additional subjects after passing Class 12th from duly recognized boards by the concerned Govt., such candidates shall be permitted to appear in NEET-UG Test and resultantly also be permitted to appear in counseling/admission process. However, their candidature will be considered only if they provide documentary evidence of having passed the qualifying Examination with the required subjects.
3. The National Medical Commission has clarified vide public notice No. U-14021/01/2024-UGMEB/pt1 dated 22.02.2025, that as per GMER-2023 the regulation's candidates studying through NIOS is allowed for appearing for NEET UG Examinations after passing the requisite qualifying examination. The students are permitted to study an additional subject from NIOS with the condition that the study needs to be carried out from any authorized institutions.

II. Age Eligibility

As per the Graduate Medical Education Regulation-2023 (Amendment) dated 16.06.2023, following amendment with respect to minimum age has been notified in GMER-2023, which mandates that:

- i) He/ She has completed the age of 17 years as on or before 31st December of the year that the candidate shall be appearing for NEET-UG examination.
- ii) Accordingly, the lower age limit shall be as under:

For Candidates of General (UR)/General-EWS	Born on or before 31.12.2009
For Candidates of SC/ST/OBC- NCL/PwBD/PwD(Category)	

- iii) Upper age limit: (As per Letter No. U-11022/2/2022-UGMEB, dated 09 March 2022 received from National Medical Commission (NMC), Under Graduate Medical Education Board (UGMEB) regarding the upper age limit) there is no upper age limit. (As per Letter No. U-14023/19/NEET (UG Exam) /UGMEB dated 13.01.2026).

III. Other Eligibility Criteria

- I. Natural father/Mother of the candidate has continuously resided in Rajasthan for period of last 10 years and the candidate has studied for at least 5 years during this period in a recognized educational institution in Rajasthan, or
- II. All those students who are bonafide residents of Rajasthan but are studying in other states will also be eligible for the allotment process, or
- III. The candidate is son/daughter of serving or retired
 - (i) Employee of Government of Rajasthan
 - (ii) Officer of All Indian Services borne on State Cadres of Rajasthan and has served for more than 3 years with State Government, or
- IV. The candidate is son/daughter of serving or retired, permanent employee of Govt. Undertaking / Corporation / Improvement Trust / Municipal Bodies / Council / Panchayat Samiti / Co-operative bodies, duly constituted by the Government of Rajasthan by an act of Law who has put in at least 3 years of service on the last date of submission of the on-line application form in the year of admission, or
- V. The candidate is son/daughter of serving/retired, permanent employee of any of the State University or Secondary Board of Education (Rajasthan) provided that employee has worked in Rajasthan for 3 years preceding the last date of submission of the on-line application form, or
- VI. Candidate is a natural son/daughter of a Serving/Retired permanent employee of Indian Defense and the employee is of Rajasthan origin irrespective of his place of posting. Provided that in case of Defense Personnel from Rajasthan origin, a certificate (**certificate proforma – A**) has to be submitted by them from the employer to the effect that his state of origin is Rajasthan at the time of his entry into

service. Eligible candidates of this category shall be admitted as per laid down criteria of priority cum merit of the Rajasthan MBBS & BDS Admissions 2026, or

- VII. Candidate is a natural son/daughter of a Serving permanent employee of Indian Defense and the employee is posted in Rajasthan (**certificate proforma – B**) at the time of last date of submission of the on-line application form for admission, or
- VIII. Candidate is a son/daughter of serving/Retired person of Para-Military Forces of India and the employee is of Rajasthan origin, irrespective of his place of posting. Provided that in case of Para-Military personal from the Rajasthan origin, a certificate (**certificate proforma – A**) has to be submitted by them from the employer to the effect that his state of origin is Rajasthan at the time of his entry into service, or
- IX. Candidate is a son/daughter of serving person of Para-Military Forces of India and the employee is posted in Rajasthan (**certificate proforma – B**) at the time of last date of submission of the on-line application form for admission, or
- X. Candidate is a son/daughter of a Judge of Rajasthan High Court subject to the condition that he/she submits an undertaking/affidavit stating that such benefit is not being claimed or availed by them in any other State, or

(Candidates falling in above clauses I to X are eligible for all types of seats, i.e. Govt./Management/NRI)

- XI. Other (**for candidates who are not covered under the above clauses from I to X**)

(Candidates selecting clause XI "Other" are eligible to apply to participate but will be considered for allotment against vacant seats (Govt./Management/NRI) available after exhausting State Merit list during / after round 3).

(Candidates selecting clause XI "Other" and having NRI eligibility will be considered for allotment against NRI seats in all rounds according to the applicable norms) (Not eligible for State reservations)

IV. Eligibility for NRI Candidates

As per order no. F.5(968)DME/LC/2018/1997 dated 29.04.2019 of Government of Rajasthan (**Annexure-2**), following will be the guidelines applicable for the admission in Under Graduate/Post Graduate, Medical/Dental courses under NRI quota in all Government, Govt. Society institutions and RUHS CMS of the State:

- 1) At least one of the parents of students should be an NRI and shall ordinarily be

- residing abroad as an NRI; or
- 2) The person who sponsors the student for admission should be a first degree relative of the student (i.e. real Brother / real Sister) and should be ordinarily residing abroad as an NRI; or
 - 3) If student is taken as a ward by some other nearest relative **[as mentioned below (i) to (v)]** such students also may be considered for admission provided the guardian has bonafidely treated the student as a ward. For this following nearest relative (NRI) of candidate, who should be ordinarily residing abroad as an NRI can only be considered:
 - i. **Real brother and sister of father i.e. real uncle and real aunt.**
 - ii. **Real brother and sister of mother i.e. real maternal uncle and maternal aunt.**
 - iii. **Father and mother of father i.e. grandfather and grandmother.**
 - iv. **Father and mother of mother i.e. maternal grandfather and maternal grandmother.**
 - v. **First degree-paternal and maternal cousins.**
 - 4) All NRI Candidate shall submit a proof being sponsor as NRI/OCI/PIO in the form of certificate issued by the Indian embassy/Ministry of external affairs, Government of India for this purpose. In the absence of that certificate a duly notarized undertaking executed by the sponsor and notarized by the Notary Public of the foreign country where the sponsor resides being submitted by the sponsor, it be treated as sufficient as to the factum of the residence of the sponsor.
 - 5) An affidavit from the sponsor that he/she looks after such student and will sponsor the entire course fee of the candidate.
 - 6) According to the direction of the State Govt.:
 - i. Round 3 counselling for NRI seats remaining vacant after round 2 shall be conducted separately before starting the round 3 allotment process for Non-NRI seat.
 - ii. The NRI seats remaining vacant on allotment of round 3 shall be converted to the seats from where the NRI Seats derived and would be filled during the round 3 allotment process of Non-NRI seats.
 - iii. The candidate who gets allotment to NRI seats in round 3 counseling shall not be eligible to participate in round 3 counselling for other seats and shall at the time of Joining submit a surety bond (Annexure 3) that if leaves the course before completion, shall be liable to pay the fee for entire course prescribed for such NRI Seat.

V. Reservation Eligibility

As per order no. F.5(968)DME/LC/2018/1997 dated 29.04.2019 of Government of Rajasthan

- a) 15% of the seats in Govt. Medical Colleges and Govt. Society Medical Colleges (RajMES) / RUHS Medical College / ESIC MC / RUHS CDS will be reserved in MBBS/BDS Course to be filled up on all India basis conducted by DGHS
- b) 24 seats, 4 in each State Medical College (6 Govt. colleges) of Rajasthan of MBBS Course will be reserved for candidates selected under the Central Government pool. The Central Government Authority will fill up these seats.

Note: The remaining seats (including 50% seats of ESIC MC) shall be treated as the State Seats and will be filled up on merit cum-preference in Rajasthan MBBS & BDS Admissions 2026 with following reservations: -

c) State Reservations (Only applicable on Rajasthan Domicile Candidates)

- i. 12% seats, after excluding the seats of sub-clauses (a), (b) above are reserved for natural born (not adopted) candidates belonging to Scheduled Tribe as notified in the Presidential Order for the State of Rajasthan and who fulfill other relevant conditions; 45% of ST seats are to be for ST candidates who are bonafide residents of scheduled area (tribal area) i.e., STA Seats;
- ii. 16% seats, after excluding the seats of sub- clause (a), (b) above are reserved for natural born (not adopted) candidate belonging to Scheduled Caste as notified in the Presidential Order for the State of Rajasthan and who fulfill other relevant conditions;
- iii. 21% seats, after excluding the seats of sub-clauses (a), (b) above are reserved for those belonging to Other Backward Classes-NCL (OBC-NCL) of the State of Rajasthan and who fulfill other relevant conditions. **Candidate must submit valid OBC Certificate for Rajasthan State issued by competent authority of Rajasthan (clearly indicating 'Non Creamy Layer')**. Refer the direction letter no. 54159, dated 09.09.2015 issued by Social Justice and Empowerment Department, Govt. of Rajasthan, Jaipur.
- iv. 5% seats, after excluding the seats of sub-clauses (a), (b) above are reserved for those belonging to Most Backward Classes-NCL (MBC-NCL) of the State of Rajasthan and who fulfill other relevant conditions. **Candidate must submit valid MBC-NCL Certificate for Rajasthan State issued by competent authority of Rajasthan (clearly indicating 'Non Creamy Layer')**. Refer the direction letter no. 54159, dated 09.09.2015 issued by Social Justice and Empowerment Department, Govt. of Rajasthan, Jaipur.
- v. 10% seats, after excluding the seats of sub-clauses (a), (b) above are reserved

for those belonging to Economically Weaker Sections (EWS) of the State of Rajasthan and who fulfill other relevant conditions. **Candidate must submit valid EWS Certificate for Rajasthan State issued by competent authority of Rajasthan (valid for financial year 2026-27).** Refer the direction letter no. 28046, dated 06.05.2022 issued by Social Justice and Empowerment Department, Govt. of Rajasthan, Jaipur.

- vi. Not less than 25%, out of each category of SC, ST, STA, OBC-NCL, MBC-NCL, EWS and unreserved category shall be filled from female candidates.
- vii. 5% seats out of each category of 16% (SC), 12% (ST), 21% (OBC), 5% (MBC), 10% EWS and the remaining shall be further reserved on Merit-cum-Priority in each category horizontally for candidates with benchmark disabilities (PwBD/PwD) in accordance with Guidelines on assessment of persons with benchmark disabilities (PwBD/PwD) for admission to MBBS Course 2026 issues by National Medical Commission vide Letter No. U-11021/24204/2026-UGMEB, dated 21.07.2026 (**Annexure 1**).

The "Eligibility Certificate" issued by 62 centers of medical assessment boards approved by MCC for the academic year 2026-27 as per norms of Regulating Authority shall only be considered. List of approved centers is attached as **Annexure 1A**.

Certificate issued by any other Government Medical College/District Hospital/Government Hospital will NOT be accepted.

Note:

The PwBD/PwD candidates must ensure that they possess the disability certificate issues for NEET UG admissions 2026, by amongst 62 centers approved by MCC.

The candidate must bring the certificate issued to them, at the time of joining.

- d) 1% seats (in Government medical/Dental colleges/ Govt. Society Medical Colleges (RajMES)/ RUHS CMS / ESIC MC / RUHS CDS) after excluding the seats of sub clauses (a), (b) are reserved horizontally on priority cum merit for the natural born (not adopted) sons/daughters of Defence Personnel (serving / retired) of Rajasthan Origin, and para military personnel (serving / retired) of Rajasthan origin (in ratio 3:1). 50% out of these reserved seats shall be reserved for girls, unfilled seats will be reverted to boys category.

As per the Kendriya Sainik Kalyan Board, the defence seat is admissible for only

one member of the family, once in lifetime. Only wards of Defence Personnel from Army, Air Force & Navy from serial 1 to 9 below are eligible for the scheme. Candidate should bring an undertaking on Rs. 50 Non-Judicial Stamp paper for compliance of letter no. F25/SKV/2022/13423-30 Dated 13.10.2022 of Sainik Kalyan Vibhag, Govt. of Rajasthan.

As per letter no. 6(1)/2017/D (Res.II), dated 19.05.2017 and its subsequent amendments in Nov. 2017 and 21.05.2018 issued by Dept. of Ex- serviceman welfare, of Govt. of India and SOP letter no. 370/Adm/MBBS/BDS/c, dated 01.07.2020 of Kendriya Sainik Kalyan Board, Ministry of Defense, Govt. of India, priority order (**certificate proforma 1**) for Defence personnel of Rajasthan origin, will be as follows:

1. (EXS1) Widows/Wards of Defence Personnel killed in action.
2. (EXS2) Wards of those Disabled in action and boarded out from service
3. (EXS3) Widows/Wards of those Defence personnel who died while in service with death attributable to military service
4. (EXS4) Wards of those Disabled in service and boarded out with disability attributable to military service.
5. (EXS5) Wards of ex-service men and serving personnel who are in receipt of Gallantry Award. (i) Paramvir Chakra (ii) Ashok Chakra (iii) Mahavir Chakra (iv) Kirti Chakra (v) Veer Chakra
6. (EXS6) Wards of ex-service men.
7. (EXS7) Wives of
 - (i) defence personnel killed in action and boarded out from service
 - (ii) defence personnel disabled in service and boarded out with disability attributable to military services
 - (iii) ex-servicemen and serving personnel who are in receipt of Gallantry Award
8. (EXS8) Wards of serving personnel
9. (EXS9) Wives of serving personnel

As per the letter no. F25/SKV/2022/13423-30 Dated 13.10.2022 of Sainik Kalyan Vibhag, Govt. of Rajasthan, the para-military seat is admissible for only one member of the family once in life time. According to the MHA (Ministry of Home Affairs), only wards of Para-military personnel from serial 1 to 3 below are eligible for the scheme. Candidate should bring an undertaking on Rs. 50 Non-Judicial Stamp paper for compliance of letter no. F25/SKV/2022/13423-30 Dated 13.10.2022 of Sainik Kalyan Vibhag, Govt. of Rajasthan.

Priority order (**certificate proforma 2**) for Para-military personnel of Rajasthan origin, will be as follows:

1. Wards/ Widows /Wives of those Paramilitary personnel killed in action.
2. Wards/ Widows /Wives of those Paramilitary personnel permanently disabled in action and boarded out from service.
3. Wards of All serving and retired personnel.

e) No reservation shall be applicable on NRI seats of all Medical/Dental Colleges.

For admission under NRI Quota in Medical/ Dental courses in the colleges in the State of Rajasthan, priority shall be given to the NRI with ancestral background of the State of Rajasthan by own/parents/Grandparents resided in State of Rajasthan at least for a period of 5 years at any time. The proof of residence will also be applicable for the consideration priority for NRI Quota, for which document (Electricity/ Water bill/ Documents of immovable property/ Indian Passport/ Ration Card/ Voter ID/ Aadhaar Card etc.) to the effect for this criteria is required to be submitted by ward of NRI (including PIO/ OCI).

Firstly, NRI Quota seats shall be allotted to candidates having ancestral background of the state of the Rajasthan by own/parents/grandparents resided in State of Rajasthan at least for the period of 5 years. Later on remaining Vacant NRI seats will be allotted/filled by the candidates of NRI belonging to other states.

For PIO/OCI: Overseas Citizens of India (OCI), Persons of Indian Origin (PIO) are allowed for admission under NRI quota.

(For detailed guidelines read this information bulletin carefully).

- f) During/after the third round of counselling the unfilled reserve seat (s) of any category from sub- clauses (c) and (d) shall be treated un-reserved and shall be filled accordingly.

5. Seat Matrix

The seat matrix for choice filling will be available on website in due course before every round.

As per regulatory body, there are 3 types of seats in Government and Government Society (RajMES) colleges namely - Government seat, Management seat and NRI seat. Responsibility of type of seats in the seat matrix shall lie with the concerned institution and not with the Counseling Board. It is on the part of the concerned medical / dental college to provide the categories of seats as well as fee to be charged for that category in accordance to the laws, rules and guidelines applicable to them.

6. Fee Details

The matter related to Fee structure of some Private Medical colleges is sub-judice in Hon'ble Rajasthan High Court Jaipur and Jodhpur Benches vide S. B. Civil Writ Petitions and also in Hon'ble Supreme Court of India, and the outcome of same shall be applicable as per Hon'ble Court directions. Fee details as provided by the concerned Institutes/Colleges will be published in due course on the Counselling Website for ready-reference of participating candidates. The Responsibility of type of seats and Fee levied on such seats shall lie with the concerned institution and not with the State Counseling Board. The Institutions are expected to get their fee structure approved from the concerned state authority at their own level.

Conditions relating to bond etc. (applicable for Government colleges/Govt. Society Colleges/RUHS CMS, RUHS CDS)

The candidates selected on Govt. seats (Except Management and NRI Seats) in above medical colleges will have to submit a bond of commitment not to leave the course before completion and to serve the State Government for 2 years after completion of the course, amounting to Rs. 10.0 lakhs (Rupees Ten lakhs).

In consonance with Govt. of Rajasthan letter no. F.7(86) CM-HM-Budget-DME-Acad.-2015-3285 dated 15.07.2021, a candidate joining on management seat in Govt. Society Colleges/RUHS CMS shall be required to submit a bond to the effect that in case he/she leaves the MBBS course before its completion, fees of all remaining semesters of the

course shall be payable by him/her.

The candidates selected against NRI seat in above medical colleges will have to submit a bond for fees of the remaining period for depositing on a regular basis. In case he/she leaves the MBBS course before its completion, fees of all remaining semesters of the course shall be payable by him/her.

The candidates selected in RUHS College of Dental Sciences and Govt. Dental College will have to submit a bond of Rs. 4.0 lakhs (Rupees four lakhs) in favour of Principal of the said college along with Bank Guarantee of Rs. 1.00 lakh. If the candidate leaves the course before its completion, the Bank Guarantee and Bond will be forfeited by the college.

Conditions relating to bond / bank guarantee etc. (applicable for private colleges)

At the time of joining (on completion of round 3), all the joined candidates of round 1, round 2 as well as round 3 will only have to submit a bond / bank guarantee* if applicable. For details, refer website of respective private colleges / contact college office.

7. Application/Registration fee

All candidates are required to deposit non-refundable application/registration fee of INR 2500/- for UR, Gen EWS, Non-domicile, INR 1500/- for SC, ST, ST-STA category candidate of Rajasthan state domicile) + applicable transaction charges.

The application/registration fee is neither refundable, nor transferable and nor adjustable for any future State UG admissions.

Any plea in this matter shall not be entertained.

Please keep the information submitted in application form confidential and do not share with anybody. If you have filled application form but have not filled your choices during the notified period, you will not be considered for allotment but will be considered subsequently subject to fulfilling the applicable conditions. No request for enabling choice filling shall be entertained after the stipulated time period. Candidates are advised to keep checking the schedule for each round and be well in time to ensure smooth participation in counselling process by avoiding last minute hassles and technical issues.

All eligible candidates who wish to participate in the counseling process must register themselves through the above mentioned website by completing Part 1 as well as Part 2 of application form.

A candidate, who fails to register by completing both Part 1 as well as Part 2 of application form, shall not be eligible to participate in the further process of counseling.

VERIFICATION OF DOCUMENTS of Defence Personnel/ Para Military/NRI Candidates

For verification of Certificate, candidate belonging to Defence Personnel / Para Military Personnel/NRI **must present personally along with relevant original certificates/documents** and one set of photocopy of the same, at given place and time. The eligibility for choice filling of NRI seats will be enabled only after physical verification requisite documents for NRI Eligibility if found eligible.

- **Rs. 10,000/- for candidates opting for BDS Course Govt. Dental College (RUHS CDS) or Private Dental Colleges.**

Choice filling for further participation for counselling shall only be enabled after depositing security amount as per the amount deposited as given above.

The Security Deposit will be forfeited if a candidate who has been allotted a seat in the Round 2 or subsequent rounds and does not join the respective institution.

Also, the Security Deposit will be forfeited if the admission gets cancelled due to any reason e.g in case the candidate gives wrong information at the time of registration (application form filling) on the basis of which a seat may be allotted and later cancelled by the Board or fails to produce the required essential documents at the time of joining (within stipulated time).

Important conditions related to security deposits and its forfeiture if applicable-

1. If a candidate joins his allotted seat in any round of counselling, his/her security amount will be adjusted in the tuition fee to be deposited for the allotted college.
2. The security amount, if not forfeited or adjusted in fee, will be refunded after completion of counseling process, to the bank account submitted at the time of application/registration.
3. If a candidate who is allotted a seat in Round 1 does not join the allotted college, he/she will be eligible for subsequent round without forfeiture of security amount.
4. Round 1 joined candidate who has not been up-graded during round 2 counseling or

has not participated in round 2 may resign without forfeiture of security amount within two days of declaration of round 2 result, failing which he will be considered as joined candidate for round 2 and rules will apply accordingly.

5. A candidate allotted a seat (fresh / upgraded) in round 2 of counseling and does not join the allotted seat; his/her security amount will be forfeited. Such candidate shall be eligible to participate in further rounds of counseling ONLY on submission of fresh application/registration (Re-registration) and on depositing the security amount again.
6. Any candidate who retains his round 1 allotted seat (after two days of declaration of result of 2nd round of counselling) and candidates who join their round 2 allotted seat will not be allowed to resign (including returning of original documents) on or before the last date of admissions as scheduled by MCC/NMC/NDC and the conditions of bond (as given in the information bulletin) shall be applicable.
7. A candidate having joined status on completion of round 2 and willing to participate for upgradation in round 3 will be eligible for participation in Round 3 of the counselling.
8. A candidate allotted a seat (fresh / upgraded) in round 3 of counseling and does not join the allotted seat, his/her security amount will be forfeited. Such candidate shall not be eligible to participate in stray vacancy round.
9. Candidates having joined status after round 3 will not be allowed to participate in Stray vacancy round.
10. A candidate who is allotted a seat in stray vacancy round and does not join the allotted seat **shall be debarred from participating in the State counseling process in any further rounds, if applicable along with forfeiture of security amount** and bond conditions shall be applicable. Such candidate shall not be eligible for participation if any further round is conducted as per direction of MCC/NMC/NDC/Honorable Courts.
11. Candidate who joins the course on allotment of round-3 counselling or retains his or her seat (allotted in earlier round) in round-3 or a candidate who joins the course on allotment in stray vacancy round, shall not be allowed to resign the course (including returning of original documents) on or before the last date of admissions as scheduled by MCC/NMC/NDC and conditions of bond (as given in the information bulletin) shall be applicable.

Note: No candidate can join two colleges/institutes at the same time. At the time of round 2 or 3 of the allotment process, such candidates who have registered for the state counseling and who have joined other college/institute (as on a specified date) through round 2 or 3 of All India counseling or any other counseling and hence as per the directions of Hon'ble Supreme Court shall be in-eligible for allotment in State round 2 or 3 and stray vacancy round.

There will be data sharing of joined candidates between center and state and any candidate whose name is any of the lists shall not be eligible for participation in Stray Vacancy Round

Stray Vacancy Round: For participation in stray vacancy round, it is mandatory for eligible candidates to get their documents verified and submit all relevant original documents along with a Bond in prescribed format, with the Board within the stipulated time period for same. Candidate whose documents are not verified or who does not submit his /her original documents along with the requisite bond, will not be allowed to participate in stray vacancy round. Documents of such candidates will be kept by the counselling board after verification and will be handed over to the respective college after joining/reporting of the candidate as per the allotment letter. The original documents of the candidates who do not get any allotment will be returned by the dates notified on personal appearance of candidate him/herself for collecting them.

10. Choice Filling

The guidelines and requirements for choice filling will be available with publication of seat matrix. Candidates must fill their choices, very carefully, based on the seat matrix and corresponding fee structure/bond conditions of respective institutions.

If a candidate does not submit his/her choice till the specified date and time, he/she will lose chance of participation in the on-line allotment process. The choices are required to be filled very carefully as the choices filled shall be final for on-line allotments for that round only.

It is mandatory to fill fresh choices in each and every round irrespective of whether the candidate was allotted/joined a seat in previous round or not (subject to the candidate is eligible to participate and willing to participate/upgrade in subsequent round). The choices filled by a candidate in previous round shall be scraped off and will not be considered for further rounds.

Note: If a candidate does not fill fresh choices for a round then he/she will not be considered for allotment / up gradation in that round.

Candidates participating in round 2 or round 3 of the counselling may fill the choices also for the virtual vacancies that may arise due to up gradation by a joined candidate of earlier round.

Candidate participating in the counselling process shall be considered on the vacancies available at his/her merit. Allotment to a candidate shall be done as per merit and filled choices as per real vacancy or virtual vacancy that may arise due to upgradation of a joined candidate.

If a round 1 allotted and joined candidate does not fill choices for round 2, then he/she will not be considered for up gradation in round 2 (as per his/her merit) and the seat allotted to him/her in round 1 will be considered retained as such.

If a round 1 / round 2 allotted and joined candidate does not fill choices for round 3, then he/she will not be considered for up gradation in round 3 (as per his/her merit) and the seat allotted to him/her in round 1 / round 2 will be considered retained as such.

11. Allotment of Seats

The allotment of seats shall be conducted strictly in accordance with the merit list prepared on the basis of All India Merit in NEET 2026 (of NEET 2026 qualified and State registered candidates), the order of choices / options filled in by the candidates in the application form (**Candidates are advised to fill the choices very carefully after referring the Fees displayed at the time of choice filling and also College Information Sheet of the respective college**).

All rounds of State NEET UG (Medical/Dental) Counseling 2026 shall be held on-line.

The minimum qualifying percentile as per press release dated 14.06.2025 by National Testing Agency:

SELECTION OF STUDENTS

- The selection of students to a Medical / Dental College shall be based solely on the All India merit of the candidate through NEET UG 2026.
- To be eligible for MBBS & BDS Admissions 2026, the candidate must have fulfilled the eligibility criteria as mentioned in this information bulletin & NTA-26 document as per MCC and NMC norms.
- The eligible qualified candidates in the NEET UG 2026 will be admitted in the order of merit for the general as well as reserved seats excepting the seats belonging to the category of the sub-clause 'e' of clause-5 (regarding defence/paramilitary wards) in which case it would be priority-cum-merit.

The allotment of seat to a candidate shall remain provisional till verification of original documents/credentials, eligibility and fulfilment of medical fitness criteria, at the allotted college.

A candidates will be deemed to have joined an institution once his/her original documents are submitted, reported physically at the desk of allotted institution at Academic block, SMS Medical College, Jaipur, at the time of reporting and have deposited the requisite one-year tuition fee.

12. Joining at the college after counselling

All candidates allotted a seat through State NEET UG Counselling for MBBS/BDS Course will have to report in-person at Academic Block, SMS Medical College, Jaipur (at the desk of the allotted college) by the notified date and time.

Round 1

The candidates admitted to all medical / dental colleges will have to deposit one year tuition fees of the allotted college (the Security amount will be adjusted in Tuition Fee) only through electronic (on-line) mode in the **bank account*** of Chairman NEET UG Counselling Board 2026, which will be handed over to the allotted college (refer the website for fee details of all participating colleges). Receipt of such electronic transaction duly verified by the bank and original documents, requisite bond will have to be submitted at the time of joining at the desk of the concerned allotted college

* This Bank account will be mentioned in allotment letter issued to the candidates and will be specific/unique to the concerned candidate only and will be meant for use ONLY by the concerned candidate while depositing the tuition fee. It is to be noted that this bank account no. will be different for each allotted candidate, so a candidate must not share this bank account no. with any other allotted candidate and also must not use bank account no. of other allotted candidate while depositing his/her tuition fee.

The candidates will also have to submit other fees / charges and complete other formalities as per guidelines given in the respective college website at the allotted college, by the date and time notified.

Round 2

The candidates admitted to all medical / dental colleges will have to deposit one year tuition fees of the allotted college (the Security amount will be adjusted in Tuition Fee) only through electronic (on-line) mode in the bank account* of Chairman NEET UG Counselling Board 2026, which will be handed over to the allotted college (refer the website for fee details of all participating colleges). Receipt of such electronic transaction duly verified by the bank and original documents, requisite bond will have to be submitted at the time of joining at the desk of the concerned allotted college.

* This Bank account will be mentioned in allotment letter issued to the candidates and will be specific/unique to the concerned candidate only and will be meant for use ONLY by the concerned candidate while depositing the tuition fee. It is to be noted that this bank account no. will be different for each allotted candidate, so a candidate must not share this bank account no. with any other allotted candidate and also must not use bank account no. of other allotted

candidate while depositing his/her tuition fee.

Round 1 allotted and joined candidates will be considered for upgradation in round 2. For this upgradation, a round 1 allotted and joined candidate is mandatorily required to fill choices for round 2. In case he/she is allotted a different seat in round 2, his/her seat allotted (and joined) in the round 1 will automatically be vacated (and will be available for allotment to other candidates) and such a candidate will be required to join at the seat allotted during round 2).

Note: Original documents and Fee deposited in round-1 of the upgraded candidates shall be transferred directly to the upgraded college and will not be handed over to the candidate.

The candidates will also have to submit other fees / charges and complete other formalities as per guidelines given in the respective college website at the allotted college, by the date and time notified.

Round 3

The candidates admitted to all medical / dental colleges will have to deposit one year tuition fees of the allotted college (the Security amount will be adjusted in Tuition Fee) only through electronic (on-line) mode in the bank account* of Chairman NEET UG Counselling Board 2026, which will be handed over to the allotted college (refer the website for fee details of all participating colleges). Receipt of such electronic transaction duly verified by the bank and original documents, requisite bond will have to be submitted at the time of joining at the desk of the concerned allotted college.

* This Bank account will be mentioned in allotment letter issued to the candidates and will be specific/unique to the concerned candidate only and will be meant for use ONLY by the concerned candidate while depositing the tuition fee. It is to be noted that this bank account no. will be different for each allotted candidate, so a candidate must not share this bank account no. with any other allotted candidate and also must not use bank account no. of other allotted candidate while depositing his/her tuition fee.

Candidates having joined status in round 2 will be considered for upgradation in round 3. For this upgradation, a candidate is mandatorily required to fill choices for round 3. In case he/she is allotted a different seat in round 3, his/her seat allotted (and joined) in the earlier round will automatically be vacated (and will be available for allotment to other candidates) and such a candidate will be required to join at the seat allotted during round 3.

The candidates who retain round 1 / round 2 allotted seats in round 3 of counselling will have to submit fees and complete other formalities as per guidelines given in the respective

college website by the last date of joining of third counseling.

Note: Original documents and Fee deposited in earlier round of the upgraded candidates shall be transferred directly to the upgraded college and will not be handed over to the candidate.

The candidates will also have to submit other fees / charges and complete other formalities as per guidelines given in the respective college website at the allotted college, by the date and time notified.

Stray Vacancy Round

The candidates who get allotment will have to deposit one year tuition fees in the **bank account*** of Chairman of NEET PG Counseling/admission Board only through electronic (on-line) mode. Candidate will then have to deposit the proof of on-line deposition of fee along with all original documents and requisite bond to the representative of allotted college (please refer to respective college website). The bank account details of counselling board for online fee deposition will be made available on the allotment letter of the individual.

* This Bank account will be mentioned in allotment letter issued to the candidates and will be specific/unique to the concerned candidate only and will be meant for use ONLY by the concerned candidate while depositing the tuition fee. It is to be noted that this bank account no. will be different for each allotted candidate, so a candidate must not share this bank account no. with any other allotted candidate and also must not use bank account no. of other allotted candidate while depositing his/her tuition fee.

The candidates will also have to submit other fees / charges and complete other formalities as per guidelines given in the respective college website at the allotted college, by the date and time notified.

Important (for all rounds)

Each candidate shall join the allotted college and course within the stipulated time period as mentioned in the allotment letter issued on-line. There is no provision for accepting any request of extension for joining date under any circumstances. The allotment made will be firm and final. Change of college/course from one place to another is not permitted. Therefore, request for the same would not be entertained by the Admission Board after the allotment.

The selected candidates should bring all the requisite documents in original and must also submit an undertaking in Proforma-7 that the submitted documents are in original along with two sets of self-attested copies of documents, at the time of joining at the allotted

college, failing which their admission shall stand cancelled. These original documents will be kept with the institution till completion of the course.

The selected candidates will be required to undergo medical examination at the allotted institution on the notified date(s).

If any candidate is not able to report for Medical Examination at the Institution on the notified date on medical grounds or due to some other circumstances beyond his/her control and his/her parent/guardian comes in person on his/her behalf for verification of the original certificates to the college he/she will be considered for provisional admission. His / Her formal admission will be confirmed only when he/she is found medically fit and fulfills other requirements as per the dates notified.

Candidates who fail to attend medical examination or found medically unfit will be disqualified for admission.

The academic session will commence from 08.09.2026.

If a candidate is pursuing study or admitted in an Institution (other than the institution allotted through this Board) and gets allotment through this Board then he/she must present the **accepted resignation/relieving letter** from the institution he/ she is pursuing studies at present, at the time of joining at the desk of the allotted college. Failure to do so will result in disqualification for admission.

A candidate **without Original certificates / documents** shall not be allowed to take admission at the allotted college under any circumstances. A candidate who has already been admitted in MBBS/BDS course and has deposited his / her certificates in any medical/dental college/ institute / university and participates in counseling (allotment process) and at the time of reporting appears with a certificate stating that **“his/her original certificates are deposited with the medical/dental college/ institute / university”** (except the college allotted through NEET-UG counseling 2026 of Rajasthan state process), will **NOT** be allowed to take admission at the allotted college.

The colleges shall be provided the list of candidates allotted. The colleges shall verify the credentials of reporting candidates as per this list and check the documents and other required certificates with originals. Joined status is to be updated on College portal. All resignations, if allowed as per notification shall be done online through College portal on physical reporting of candidate with resignation letter. The college shall update the resignation of allotted seat on the college portal and print two copies of online generated resignation letter. One copy must be handed over to the candidate with the sign of Head of Institute/ Nodal Officer/ designated authority for same.

The admissions shall be treated as provisional subject to the final decision of any pending case(s) in any court of law, if applicable to these admissions. Further, the provisional status

of admission shall stand cleared only after enrolment by the concerned University.

The non-viewing of the websites about allotment information by the candidate shall not be accepted as a ground for non-joining by the scheduled time and date. The candidate's allotment will stand automatically cancelled if he/she does not join IN PERSON at the allotted college as per the notified schedule.

IMPERSONATION

If at any stage, it is found that any candidate has indulged in any case of impersonation i.e. not matching the biometric/ photograph/ signature/ videography/ documents of the candidate etc. he/she will be handed over to the Police and the cases will be dealt as per the Indian Penal Code. **Such candidates will be debarred permanently from taking MBBS/BDS Admissions in Future.**

The jurisdiction for legal cases arising out of Rajasthan MBBS & BDS Admissions 2026 shall be High Court of Rajasthan.

The decision of the Admission Board in all aspects and all respects pertaining to the application and its acceptance or rejection as the case may be, conducting of counseling and at all consequent stages culminating in the admission or otherwise of any candidate shall be final in all respects and binding on all concerned.

Before filling the on-line application form, read the information bulletin and instructions for filling on-line application form etc. very carefully.

First ensure your eligibility (educational qualification, age etc.) and other requirements for admission as given in the information bulletin etc.

You should be very careful in filling-up the on-line application form. If any lapse is detected during the scrutiny, your candidature will be rejected at any time of admission process or even at a later stage.

In case you have any difficulty while filling on-line application form, send email to the grievance e-mail id as mentioned on the website

The processing of application form is based on the information filled by the candidate.

Any error committed intentionally or otherwise may result in cancellation of your candidature.

Important:

Note down your Application Form No. (Registration ID/ Username) and password carefully. Keep them safe with you for further processing. Don't disclose this information to anyone else.

12. Disclaimer

The apex court drew guidelines for the management of all educational institutions to follow. Among them:

Educational institutions should take anti-ragging measures right from the time of advertisement for admissions. The prospectus, the form for admission and/or any other literature issued to aspirants for admission must clearly mention that ragging is banned in the institution and anyone indulging in it is likely to be punished appropriately which may include expulsion from the institution, suspension from the institution or classes for a limited period or fine with a public apology.

The punishment may also take the shape of: (i) withholding scholarships or other benefits (ii) debarring from representation in events (iii) withholding results (iv) suspension or expulsion from hostel or mess. If there be any legislation governing ragging or any provisions in statute/ordinance, it should be brought to the notice of the students/parents seeking admissions. A printed leaflet detailing when and to whom a victim may turn for information, help and guidance for various purposes, keeping in view the needs of new entrants, along with their addresses and telephone numbers should be given to fresher at the time of admissions so that they need not to look to seniors for help in such matters.

GUIDELINES ON ASSESSMENT OF PERSONS WITH BENCHMARK DISABILITIES (PwBD) FOR ADMISSION TO THE MBBS COURSE, 2026

U-11021/24204/2026-UGMEB-In exercise of the powers conferred by Sections 10 and 24 of the National Medical Commission Act, 2019, read with Section 57 thereof, and in furtherance of the Graduate Medical Education Regulations, 2023, the National Medical Commission hereby issues the following Guidelines, namely: —

1. Short Title and Commencement

- These Guidelines may be called the "Guidelines on Assessment of Persons with Benchmark Disabilities (PwBD) for Admission to the MBBS Course, 2026".
- They shall come into force on the date of their publication by the National Medical Commission.

2. Objectives

- The National Medical Commission recognises that Persons with Benchmark Disabilities constitute an integral part of society and are entitled to equality, dignity, non-discrimination and reasonable accommodation in all spheres of life, including medical education, in accordance with the Constitution of India and the Rights of Persons with Disabilities Act, 2016.
- Simultaneously, the National Medical Commission is entrusted with the statutory responsibility of maintaining high standards of undergraduate medical education and ensuring that every medical graduate acquires the essential competencies necessary for the safe, ethical and effective practice of modern medicine in accordance with the Competency Based Medical Education (CBME) curriculum.
- Medical education demands the acquisition of knowledge, professional skills, clinical competencies, communication abilities and ethical values. The

assessment of candidates with benchmark disabilities must therefore balance the rights guaranteed under the Rights of Persons with Disabilities Act, 2016 with the statutory obligation to maintain academic standards, professional competence and patient safety.

- These Guidelines introduce a competency-based and function-oriented assessment framework, whereby the determination of eligibility shall not rest solely upon the numerical percentage or category of disability reflected in the UDID Card or other disability certification. While the benchmark disability prescribed under the Rights of Persons with Disabilities Act, 2016 shall continue to determine eligibility for reservation under the PwBD category, admission to the MBBS Course shall be based upon an objective evaluation of the candidate's functional competencies, with due regard to reasonable accommodation, assistive technology, environmental accessibility and contemporary advances in rehabilitation science.
- For the purposes of these Guidelines, the certificate presently issued by the designated Medical Boards for admission to the MBBS Course, though commonly referred to as a **"Disability Certificate"**, shall be known as the **"Eligibility Certificate"**, as it is intended to certify the candidate's eligibility or otherwise for admission to the MBBS Course based on functional assessment rather than merely certifying the existence or extent of disability.
- In order to facilitate greater accessibility, transparency and uniformity in the assessment process, the network of designated assessment centres has been expanded from **sixteen (16) to thirty-three (33)** Medical Boards across the country. For the purposes of these Guidelines, all such designated Boards shall be collectively referred to as the **"Medical Assessment Boards"**, which shall undertake the functional assessment of candidates in accordance with these Guidelines.
- These Guidelines accordingly establish a transparent, uniform, evidence-based and competency-oriented framework for the assessment of Persons with Benchmark Disabilities seeking admission to the MBBS Course throughout the country, with the objective of ensuring equal opportunity while preserving academic standards, professional competence and patient safety.

3. Definitions

In these Guidelines, unless the context otherwise requires—

- **"Act"** means the National Medical Commission Act, 2019 (30 of 2019).
- **"Ability Assessment Board" or "Medical Assessment Board"** means an Assessment Board designated or constituted by the Medical Counselling Committee for assessing the functional competency and eligibility of Persons with Benchmark Disabilities for admission to the MBBS Course under these Guidelines.
- **"PwBD Candidate"** means a person seeking admission to the MBBS Course under the Persons with Benchmark Disabilities (PwBD) category through the National Eligibility-cum-Entrance Test (Undergraduate) [NEET (UG)].
- **"CBME"** means the Competency Based Medical Education curriculum prescribed by the National Medical Commission from time to time.
- **"Competency"** means the knowledge, skills, attitudes, values and professional behaviours prescribed under the Competency Based Medical Education curriculum required to successfully complete the MBBS Course.
- **"Department of Empowerment of Persons with Disabilities (Divyangjan)"** means the Department of Empowerment of Persons with Disabilities under the Ministry of Social Justice and Empowerment, Government of India.
- **"Disability Certificate"** means the certificate issued by the Ability Assessment Board/ Medical Assessment Board designated by the Medical Counselling Committee (MCC) under the

Directorate General of Health Services (DGHS), Ministry of Health and Family Welfare, Government of India, certifying the eligibility or otherwise of a Person with Benchmark Disability for admission to the MBBS Course in accordance with these Guidelines.

- **"Essential Competencies"** means the minimum competencies prescribed under the Competency Based Medical Education curriculum that every medical graduate is required to acquire for the safe and effective practice of medicine.
- **"Functional Competency"** means the demonstrated ability of a candidate, with or without reasonable accommodation or assistive technology, to acquire and perform the essential competencies required under the Competency Based Medical Education curriculum.
- **"Graduate Medical Education Regulations" or "GMER"** means the Graduate Medical Education Regulations, 2023, as amended from time to time.
- **"Guidelines"** means these Guidelines on Assessment of Persons with Benchmark Disabilities (PwBD) for Admission to the MBBS Course, 2026.
- **"Medical College"** means a medical institution recognised under the National Medical Commission Act, 2019 for conducting the MBBS Course.
- **"Medical Counselling Committee (MCC)"** means the Medical Counselling Committee constituted by the Directorate General of Health Services, Ministry of Health and Family Welfare, Government of India.
- **"National Medical Commission" or "NMC"** means the National Medical Commission established under Section 3 of the National Medical Commission Act, 2019.
- **"NEET (UG)"** means the National Eligibility-cum-Entrance Test (Undergraduate) conducted for admission to undergraduate medical education in accordance with the applicable law.
- **"Notification of 12th March, 2024"** means the Notification dated 12th March, 2024 issued by the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment, published in the Gazette of India on 14th March, 2024.
- **"Person with Benchmark Disability" or "PwBD"** shall have the same meaning as assigned to it under Section 2(r) of the Rights of Persons with Disabilities Act, 2016.
- **"Reasonable Accommodation"** shall have the same meaning as assigned to it under Section 2(y) of the Rights of Persons with Disabilities Act, 2016.
- **"Rules"** means the Rights of Persons with Disabilities Rules, 2017, as amended from time to time.
- **"Specified Disability"** shall have the same meaning as assigned to it under the Schedule to the Rights of Persons with Disabilities Act, 2016.
- **"State Counselling Authority"** means the authority designated by the respective State Government or Union Territory Administration to conduct counselling for admission to the MBBS Course.
- **"Self-certified Affidavit"** means the affidavit furnished by a candidate in the format prescribed in Schedule-I declaring the candidate's functional abilities and other particulars required under these Guidelines.
- **"Speaking Order"** means a written order containing the reasons, findings and conclusions of the Medical Assessment Board in support of its decision.
- **"Reasoned Decision"** means a decision supported by objective findings, functional assessment and reasons recorded in writing.
- **"UDID Card"** means the Unique Disability Identity Card issued through the Unique Disability Identity (UDID) Portal by the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment, Government of India.

CHAPTER I

PRELIMINARY

4. Scope and Application

4.1. These Guidelines shall apply to—

1. every candidate seeking admission to the MBBS Course under the Persons with

Benchmark Disabilities (PwBD) category;

2. every Medical College recognised under the National Medical Commission Act, 2019;
3. the Medical Counselling Committee (MCC);
4. all State Counselling Authorities;
5. all Medical Assessment Boards constituted for assessment of PwBD candidates; and
6. every authority or institution involved in the assessment, counselling, admission or certification of candidates under the PwBD category.

5. Objectives

I. The National Medical Commission recognises that Persons with Benchmark Disabilities constitute an integral part of society and are entitled to equality, dignity, non-discrimination and reasonable accommodation in all spheres of life, including medical education, in accordance with the Constitution of India and the Rights of Persons with Disabilities Act, 2016.

II. Simultaneously, the National Medical Commission is entrusted with the statutory responsibility of maintaining high standards of undergraduate medical education and ensuring that every medical graduate acquires the essential competencies necessary for the safe, ethical and effective practice of modern medicine in accordance with the Competency Based Medical Education (CBME) curriculum.

III. Medical education demands the acquisition of knowledge, professional skills, clinical competencies, communication abilities and ethical values. The assessment of candidates with benchmark disabilities must therefore balance the rights guaranteed under the Rights of Persons with Disabilities Act, 2016 with the statutory obligation to maintain academic standards, professional competence and patient safety.

IV. Disability shall not, by itself, constitute a ground for exclusion from medical education. Eligibility shall be determined through an objective assessment of the candidate's functional competencies, taking into consideration reasonable accommodation, assistive technology, environmental accessibility and contemporary advances in rehabilitation science.

V. These Guidelines seek to establish a transparent, uniform, evidence-based and competency-oriented framework for the assessment of Persons with Benchmark Disabilities seeking admission to the MBBS Course throughout the country.

6. Statutory Framework

- a. These Guidelines shall be read in conjunction with—
 - i. the National Medical Commission Act, 2019;
 - ii. the Rights of Persons with Disabilities Act, 2016;
 - iii. the Graduate Medical Education Regulations, 2023, as amended from time to time;
 - iv. the Notification dated 12th March, 2024 issued by the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment;
 - v. all applicable Regulations, Guidelines, Notifications and Circulars issued by the National Medical Commission from time to time; and
 - vi. all binding judgments, directions and orders of the Hon'ble Supreme Court of India and other competent Courts governing admission of Persons with Benchmark Disabilities to the MBBS Course.

7. Purpose

- The purpose of these Guidelines is to—
 - establish a uniform national framework for assessment of Persons with Benchmark Disabilities seeking admission to the MBBS Course;
 - ensure transparency, consistency and objectivity in disability

assessment;

- facilitate implementation of the Graduate Medical Education Regulations, 2023;
- ensure compliance with the Rights of Persons with Disabilities Act, 2016;
- promote equality, inclusion and reasonable accommodation while preserving patient safety and academic standards.

8. Equality and Non-discrimination

- The minimum degree of disability should be 40% (Benchmark Disability) in order to be eligible for availing reservation for persons with specified disability. Every PwBD candidate possessing a specified disability shall be entitled to equal treatment throughout the admission process.
- No authority shall discriminate against any PwBD candidate solely by reason of disability.
- Disability shall never be treated as a disqualification unless such disability demonstrably prevents the acquisition of essential competencies despite reasonable accommodation.
- Disability shall be understood in accordance with the rights recognized under the Rights of Persons with Disabilities Act, 2016.
- Assessment shall recognize that disability arises from the interaction between an individual's impairment and environmental, institutional, social and attitudinal barriers.
- Efforts should be made to the extent to which reasonable accommodation, assistive technology and accessible educational practices, that can enable the candidate to successfully pursue medical education.

CHAPTER II

ELIGIBILITY, DOCUMENTATION AND DISABILITY ASSESSMENT

9. Eligibility and Documentation

- A candidate seeking admission to the MBBS Course under the Persons with Benchmark Disabilities (PwBD) category shall possess a benchmark disability of not less than forty per cent (40%), in accordance with the Rights of Persons with Disabilities Act, 2016 and the rules made thereunder.
- Every such candidate shall possess a valid Permanent Unique Disability Identity (UDID) Card issued through the UDID Portal by the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment, Government of India. The UDID Card shall serve as the primary documentary evidence of the existence, nature and extent of the specified disability for the purposes of these Guidelines.
- While the particulars recorded in the Permanent UDID Card, including the category, percentage and validity of the specified disability, shall ordinarily form the basis of consideration by the Medical Assessment Board, the Board shall independently determine the candidate's functional competency in accordance with these Guidelines. The determination of eligibility shall not be based solely upon the category or percentage of disability recorded in the UDID Card.
- Where the Medical Assessment Board considers it necessary for determining the functional competency of the candidate or the feasibility of providing reasonable accommodation, it may require the candidate to undergo such further clinical examination, functional

evaluation or verification as it considers appropriate.

- Every candidate shall submit a self-certified affidavit declaring his or her functional abilities in the format specified in **Schedule-I**, which shall be verified by the Medical Assessment Board during the course of assessment.
- A candidate shall not be denied consideration under the PwBD category solely on account of a procedural defect or discrepancy in the Permanent UDID Card, provided that such defect is capable of rectification and the specified disability is otherwise established in accordance with law.
- Every admission to the MBBS Course under the PwBD category shall be regulated by these Guidelines, and every Medical College, Counselling Authority and Medical Assessment Board shall ensure strict compliance with the provisions contained herein.

10. Medical Assessment Board/Ability Assessment Board

- Every Medical Assessment Board shall discharge its functions fairly, objectively, transparently and in accordance with the principles of natural justice, equity and the rule of law.
- Every candidate appearing before the Medical Assessment Board shall be treated with dignity, respect and fairness throughout the assessment process.
- The Medical Assessment Board shall ensure that no candidate is subjected to physical, environmental, communication or attitudinal barriers during the assessment process.
- The Medical Assessment Board shall undertake the assessment of candidates in accordance with—
- the assessment methodology prescribed under the Notification dated 12th March, 2024 issued by the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment;
- these Guidelines; and
- any other applicable statutory provisions governing the assessment of Persons with Benchmark Disabilities.

11. Matters to be Verified and Evaluated

a. While assessing the eligibility of a candidate under these Guidelines, the Medical Assessment Board shall verify and evaluate, inter alia—

- i. the Permanent Unique Disability Identity (UDID) Card issued by the competent authority under the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment;
- ii. the nature, extent and stability of the specified disability and the underlying medical condition;
- iii. the candidate's functional abilities in relation to the essential competencies prescribed under the Competency Based Medical Education (CBME) curriculum;
- iv. the suitability and effectiveness of any assistive device, assistive technology or adaptive aid used by the candidate;
- v. the feasibility of providing reasonable accommodation to facilitate acquisition of the prescribed competencies;
- vi. the impact, if any, of the disability upon patient safety; and
- vii. such other clinical, functional or educational factors as may be relevant for

determining the candidate's eligibility under these Guidelines.

b. Principles Governing Determination of Eligibility

The determination of eligibility by the Medical Assessment Board shall be guided by the following principles—

i. Functional Competency

The primary consideration shall be whether the candidate possesses, or can reasonably acquire with appropriate support and reasonable accommodation, the essential competencies prescribed under the Competency Based Medical Education (CBME) curriculum.

ii. Individualized Assessment

Every assessment shall be individualized, objective and evidence-based. No candidate shall be declared eligible or ineligible solely on account of the category or percentage of disability.

iii. Scientific Assessment

Assessment shall be based upon objective medical findings, scientific evidence, functional evaluation, contemporary rehabilitation principles and evidence-based medical practice. The Medical Assessment Board shall avoid reliance upon outdated medical opinions, stereotypes or unsupported assumptions relating to disability. Where advances in rehabilitation medicine, assistive technology or adaptive devices substantially improve the functional abilities of the candidate, due consideration shall be given to such advancements while determining eligibility.

iv. Reasonable Accommodation

Prior to declaring a candidate ineligible, the Medical Assessment Board shall examine whether reasonable accommodation, assistive technology, adaptive devices or appropriate infrastructural support would enable the candidate to successfully pursue and complete the MBBS Course without compromising the acquisition of the prescribed competencies.

Provision of reasonable accommodation shall not be construed as dilution of academic standards but shall constitute a measure to ensure substantive equality of opportunity for Persons with Benchmark Disabilities.

Reasonable accommodation may include, inter alia—

1. assistive devices;
2. adaptive equipment;
3. digital accessibility;
4. accessible teaching and learning material;
5. communication support;
6. ergonomic modifications;
7. examination accommodations consistent with academic standards; and
8. accessible clinical learning environments.

Patient Safety

Patient safety shall remain an important consideration while determining eligibility. However, any conclusion relating to patient safety shall be based upon objective clinical and functional evidence and shall not rest upon generalized assumptions, stereotypes or preconceived notions regarding disability.

Chapter-III

Procedure for issuance of Certificate to the PwBD Candidate and Review Mechanism

12. Procedure for issuance of Certificate to the PwBD Candidate

- a. Upon completion of the functional assessment, the Medical Assessment Board shall determine whether the candidate is Eligible; Eligible with Reasonable Accommodation, or Ineligible for admission to the MBBS Course under the Persons with Benchmark Disabilities (PwBD) category in accordance with these Guidelines.
- b. The determination of eligibility shall be based on—
 1. the candidate's demonstrated functional competency in relation to the essential competencies prescribed under the Competency Based Medical Education (CBME) curriculum;
 2. the feasibility of providing reasonable accommodation, assistive technology or other support measures, wherever appropriate;
 3. the ability of the candidate to successfully complete the MBBS Course and acquire the prescribed competencies; and
 4. considerations relating to patient safety, supported by objective medical and functional evidence.
- c. No candidate shall be declared ineligible solely on the basis of—
 1. the diagnosis or category of disability;
 2. the percentage of benchmark disability recorded in the UDID Card or Disability Certificate; or
 3. generalized assumptions or stereotypes associated with any disability.
- d. A candidate shall be declared ineligible only where the Medical Assessment Board, after due consideration of reasonable accommodation and assistive technology, records, by a reasoned and speaking order, that the candidate is unable to acquire the essential competencies prescribed under the Competency Based Medical Education (CBME) curriculum or that the disability would pose a demonstrable and unacceptable risk to patient safety which cannot be mitigated through reasonable accommodation.
- e. Every determination of the Medical Assessment Board shall be recorded in writing and shall clearly specify—
 - i. the nature and extent of the disability;
 - ii. the findings of the functional competency assessment;
 - iii. the reasonable accommodation, if any, considered or recommended;
 - iv. the reasons supporting the determination of eligibility or ineligibility; and
 - v. the final recommendation of the Board.
- f. The Medical Assessment Board shall issue an **Eligibility Certificate**, in the format specified in **Schedule-II**, certifying whether the candidate is—
 - a) Eligible;
 - b) Eligible with Reasonable Accommodation, specifying the accommodation(s) recommended; or
 - c) Ineligible, together with the reasons recorded in accordance with clause 12.4.

Review Mechanism

- g. Any candidate aggrieved by the findings or decision of the Medical Assessment Board may seek a review before any other Medical Assessment Board /Ability Assessment Board designated by the Medical Counselling Committee (MCC), within such time and in such manner as may be notified by the Medical Counselling Committee from time to time.

- h.** The designated Medical Assessment Board /Ability Assessment Board shall independently assess the candidate in accordance with these Guidelines and may examine the candidate afresh, review the relevant records, or undertake such further clinical examination or functional assessment as it considers necessary. The designated Medical Assessment Board /Ability Assessment Board shall record its findings by a reasoned and speaking order, clearly indicating the basis for affirming, modifying or setting aside the findings of the earlier Medical Assessment Board /Ability Assessment Board.
- i.** The decision of the designated Medical Assessment Board /Ability Assessment Board shall be final for the purposes of counselling and admission under these Guidelines, subject to any order or direction of a court of competent jurisdiction.

CHAPTER VI

MISCELLANEOUS

13. Institutional Responsibilities

- a.** Every Medical College, Medical Counselling Committee, State Counselling Authority and Medical Assessment Board shall ensure that the provisions of these Guidelines are implemented in letter and spirit.
- b.** Every institution shall take appropriate measures to ensure that no PwBD candidate is denied admission or subjected to discrimination solely on the ground of disability, except in accordance with these Guidelines and the applicable statutory provisions.
- c.** Every institution shall endeavour to provide reasonable accommodation, barrier-free access and accessible learning environments in accordance with the Rights of Persons with Disabilities Act, 2016 and the applicable standards notified by the Government of India.
- d.** Medical Colleges are encouraged to undertake periodic sensitization and capacity-building programmes for faculty members, administrative staff and students to promote an inclusive academic environment and eliminate physical, communication and attitudinal barriers.
- e.** Every Medical College shall designate a Nodal Officer or establish an appropriate institutional mechanism to facilitate implementation of these Guidelines and to address issues concerning PwBD candidates. These measures reflect the institutional responsibilities emphasized under the Rights of Persons with Disabilities Act, 2016 and the interim framework previously adopted by the Commission.

14. Grievance Redressal Mechanism

- a.** Every Medical College and Counselling Authority shall maintain an effective, accessible and time-bound grievance redressal mechanism for addressing complaints relating to disability assessment, denial of reasonable accommodation or any act of discrimination against PwBD candidates.
- b.** Every grievance shall be dealt with fairly, expeditiously and in accordance with the applicable provisions of law.

15. Compliance

- a.** Every admission to the MBBS Course under the Persons with Benchmark Disabilities category shall be governed by these Guidelines.
- b.** Every authority concerned with the admission process shall strictly comply with these Guidelines.
- c.** No Medical Assessment Board shall declare a candidate ineligible without recording reasons in writing based upon functional assessment, scientific evidence and the principles contained in these Guidelines.
- d.** Every recommendation of the Medical Assessment Board shall be made by a reasoned and speaking order.

16. Power to Issue Clarifications

The National Medical Commission may issue such clarifications, advisories, standard operating procedures or procedural instructions, consistent with these Guidelines and the National Medical Commission Act, 2019, as may be necessary for their effective and uniform implementation.

17. Interpretation

If any question arises regarding the interpretation or implementation of these Guidelines, the matter shall be referred to the National Medical Commission whose decision thereon shall be final, subject to the provisions of the National Medical Commission Act, 2019, the Rights of Persons with Disabilities Act, 2016 and any judgment or direction of a competent Court.

18. Repeal and Saving Clause

- a. These Guidelines shall supersede all previous guidelines, advisories and instructions issued by the National Medical Commission or the erstwhile Medical Council of India relating to the assessment of Persons with Benchmark Disabilities for admission to the MBBS Course, to the extent they are inconsistent with these Guidelines.
- b. Notwithstanding such supersession, any action taken, assessment conducted or decision made under the earlier guidelines shall be deemed to have been validly taken or made insofar as it is not inconsistent with these Guidelines.

19. Overriding Principle

While implementing these Guidelines, every authority shall ensure that the assessment of a candidate is based upon functional competency, objective medical evidence and the possibility of reasonable accommodation. No candidate shall be denied consideration or declared ineligible solely on the basis of diagnosis, disability category or generalized assumptions regarding disability. The paramount considerations shall be equality of opportunity, maintenance of academic standards and patient safety, to be harmoniously applied in accordance with the National Medical Commission Act, 2019 and the Regulations and Guidelines framed thereunder and the Rights of Persons with Disabilities Act, 2016.

In supersession of the previous orders dated 24-8-2011 and F.7(6)NRI/DME/Acad/2017/3486 dated 19-6-2018 issued earlier by the State regarding filling up seats of NRI quota till date, Following will be the guidelines applicable for the admission in Under Graduate/Post-Graduate, Medical/Dental Courses under NRI quota in all Private and Government Institutions of the State:-

1. A. At least one of the parents of students should be an NRI and shall ordinarily be residing abroad as an NRI; or
B. The person who sponsors the student for admission should be a first degree relative of the student (i.e. real Brother/real Sister) and should be ordinarily residing abroad as an NRI; or
C. If student is taken as a ward by some other nearest relative [as mentioned below (i) to (v)], such student may also be considered for admission provided the guardian has bonafidely treated the student as a ward. For this, following nearest relative (NRI) of candidate, who should be ordinarily residing abroad as an NRI can only be considered:-
 - i. Real brother and sister of father i.e. real uncle and real aunt.
 - ii. Real brother and sister of mother i.e. real maternal uncle and maternal aunt.
 - iii. Father and mother of father i.e. grandfather and grandmother.
 - iv. Father and mother of mother i.e. maternal grandfather and maternal grandmother.
 - v. First degree-paternal and maternal cousins.
2. For PIO / OCI:- Persons of Indian Origin (PIOs), Overseas Citizen of India (OCIs) are allowed for admission under NRI Quota in UG and PG (Medical /Dental) courses in the State of Rajasthan.
3. All NRI Candidate shall submit a proof of being sponsor as NRI/OCI/PIO in the form of certificate issued by the Indian embassy/Ministry of external affairs, Government of India for this purpose. In the absence of that certificate a duly notarized affidavit executed by the sponsor and notarized by the Notary Public of the foreign country where the sponsor resides being submitted by the sponsor, it be treated as sufficient as to the factum of the residence of the sponsor.
4. An affidavit from the sponsor that he/she looks after such student and will sponsor the entire fee of the candidate.

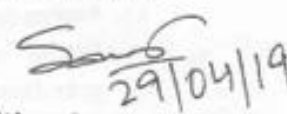

- 1- **For NRI belong to the State of Rajasthan :-** The Proof of residence will also be applicable for the consideration priority for NRI Quota in place of the candidate who belongs to other State.

Priority shall be given to the NRI with ancestral back ground of the State of Rajasthan by own/ parents / Grandparents resided in State of Rajasthan at least for a period of 5 years at any time. For which documents (Electricity /water bill/ Documents of immovable property/ Indian Passport/ Ration Card /Voter ID/Aadhar Card etc.) to the effect for this criteria is required to be submitted by ward of NRI (including PIO / OCI).

Firstly allotments of NRI quota in UG and PG seats shall be allotted to candidate having ancestral back ground of the State of Rajasthan by own/ parents / Grandparents resided in State of Rajasthan at least for a period of 5 years. Extension remaining Vacant NRI-seats may be allotted/ filled by the candidates of NRI belong to other states.

- 2- **For PIO / OCI (Oversees Citizen of India (OCIs), Persons of Indian Origin (PIOs)):-** Oversees Citizen of India (OCIs), Persons of Indian Origin (PIOs) are allowed for admission under NRI Quota in UG and PG (Medical /Dental) courses in the State of Rajasthan.

This will be applicable from the session 2018-19 & onwards.
